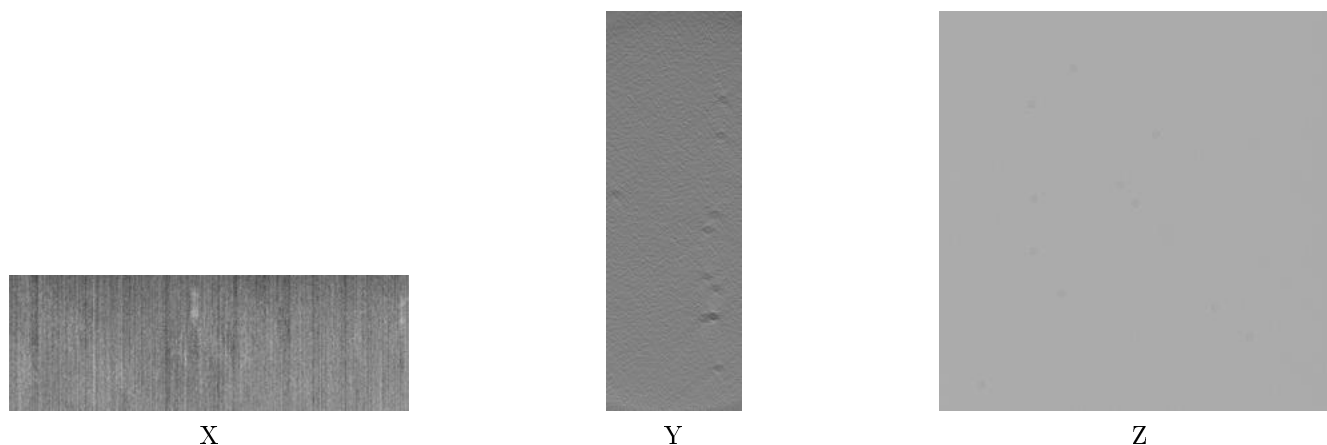

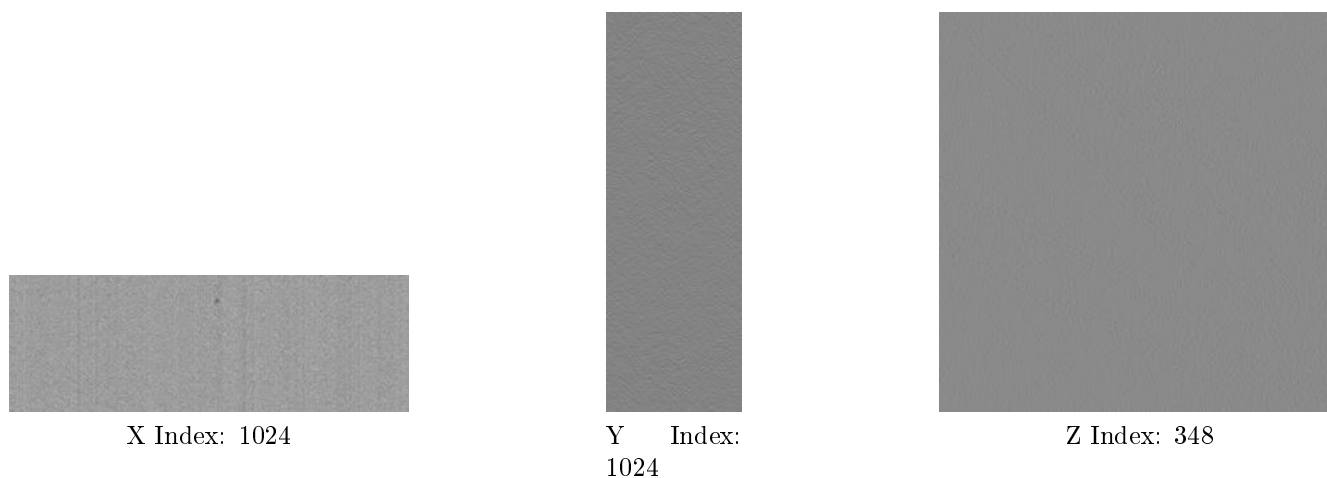

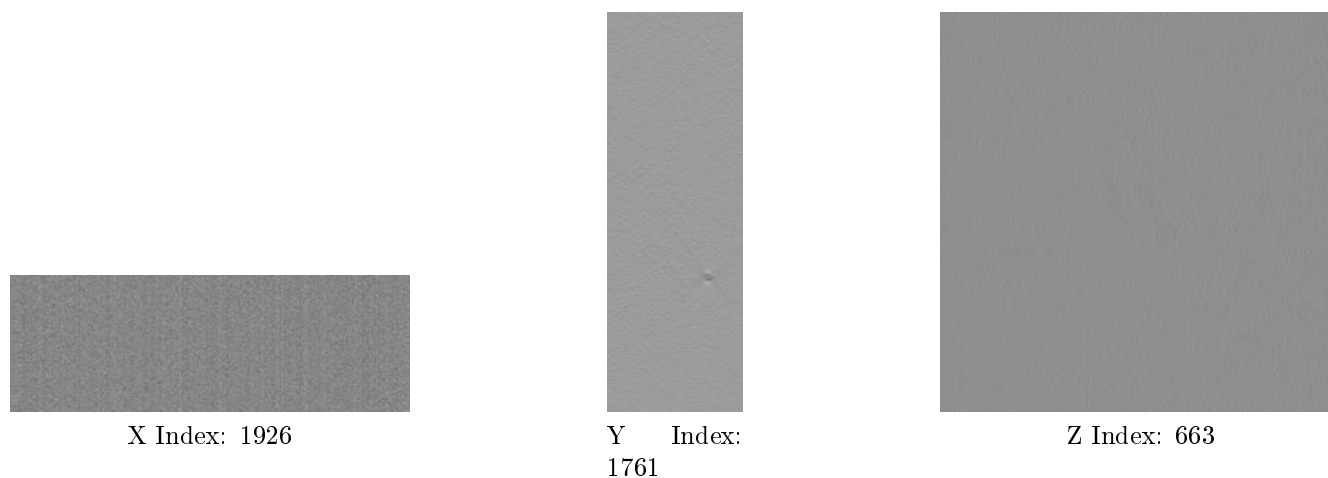
The images above show the tomogram projected in three orthogonal directions.

The images above show the largest variance slices of the tomogram in three orthogonal directions.

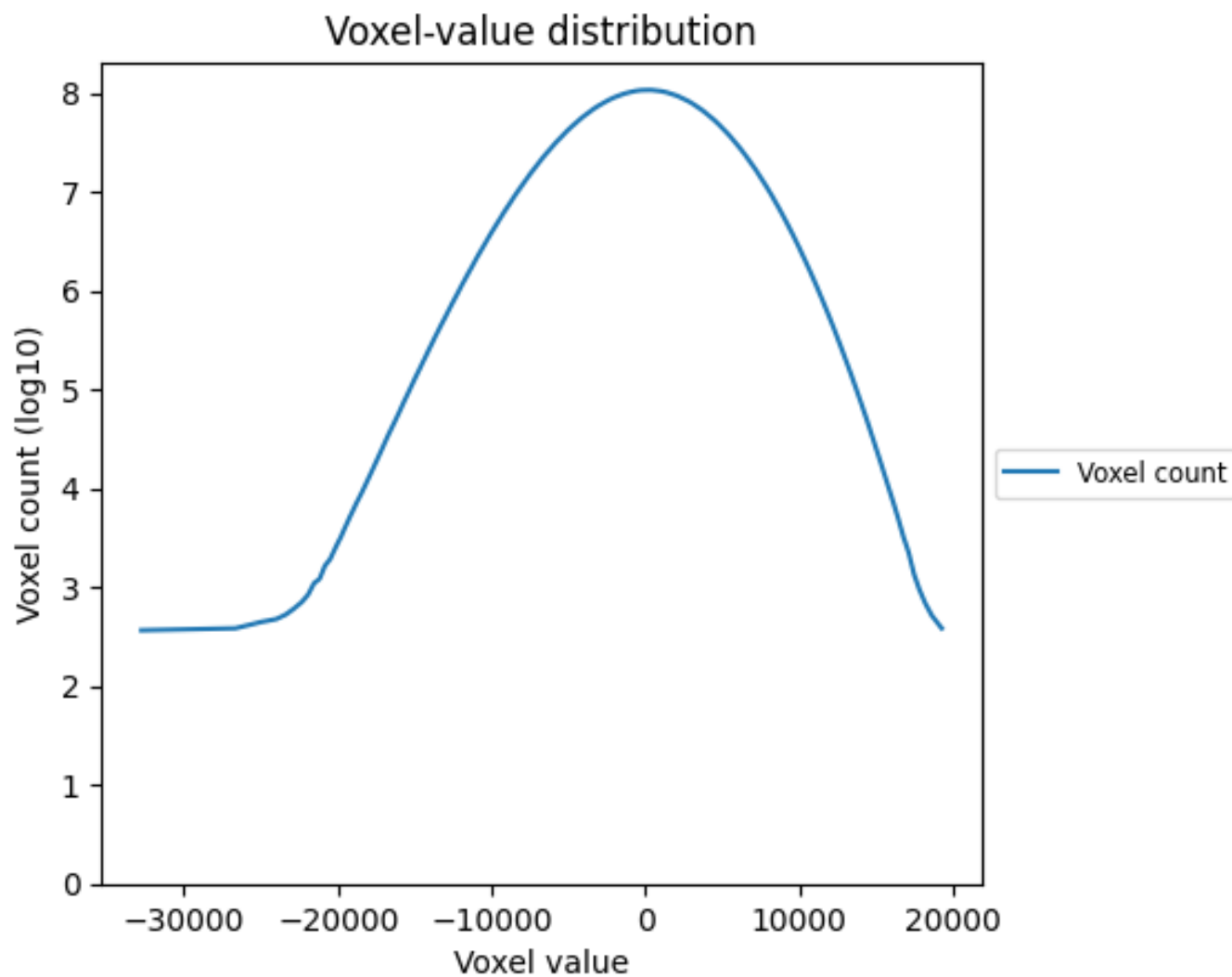
