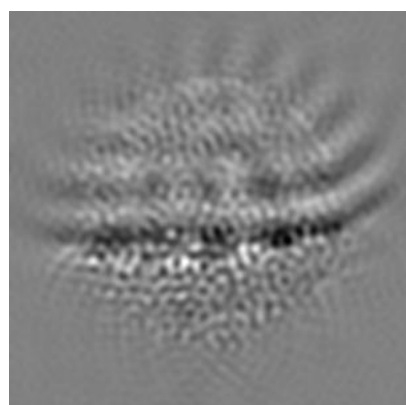
## 2 Map visualisation [i](#)

This section contains visualisations of the EMDB entry EMD-2690. These allow visual inspection of the internal detail of the map and identification of artifacts.

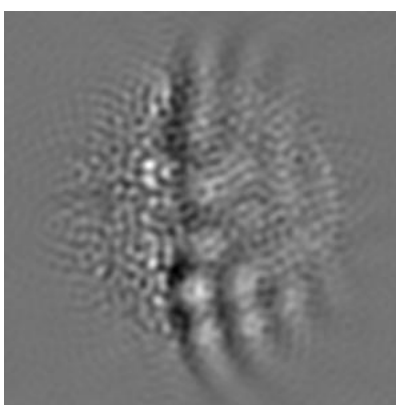

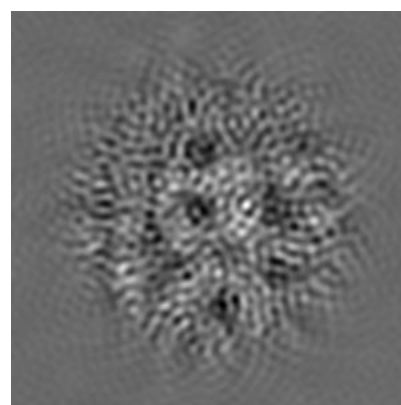

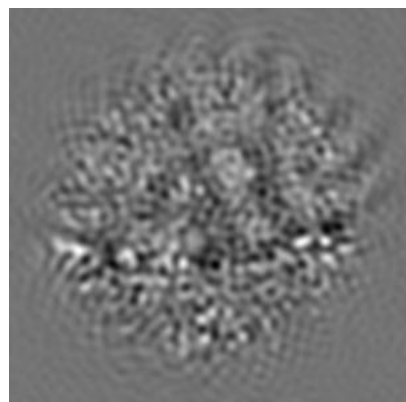

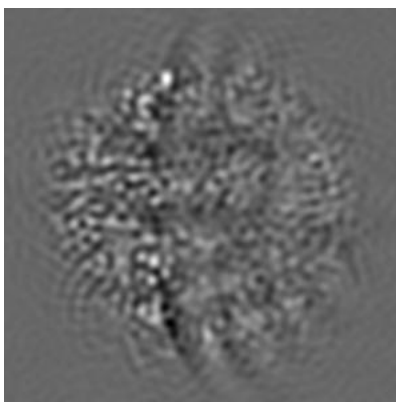
The images above show the map projected in three orthogonal directions.

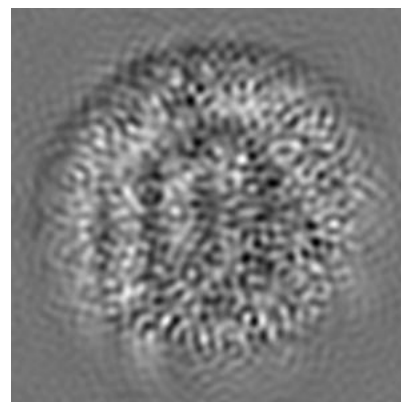

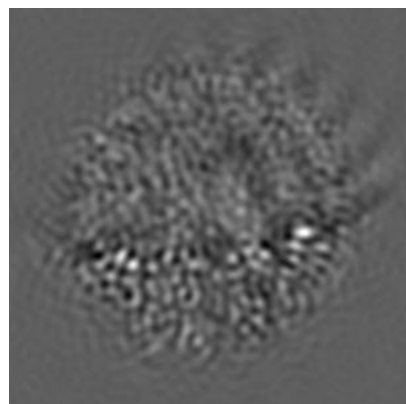

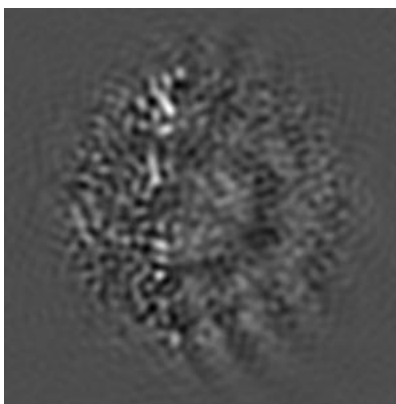
The images above show central slices of the map in three orthogonal directions.

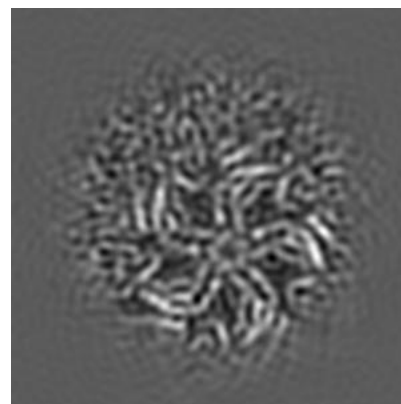

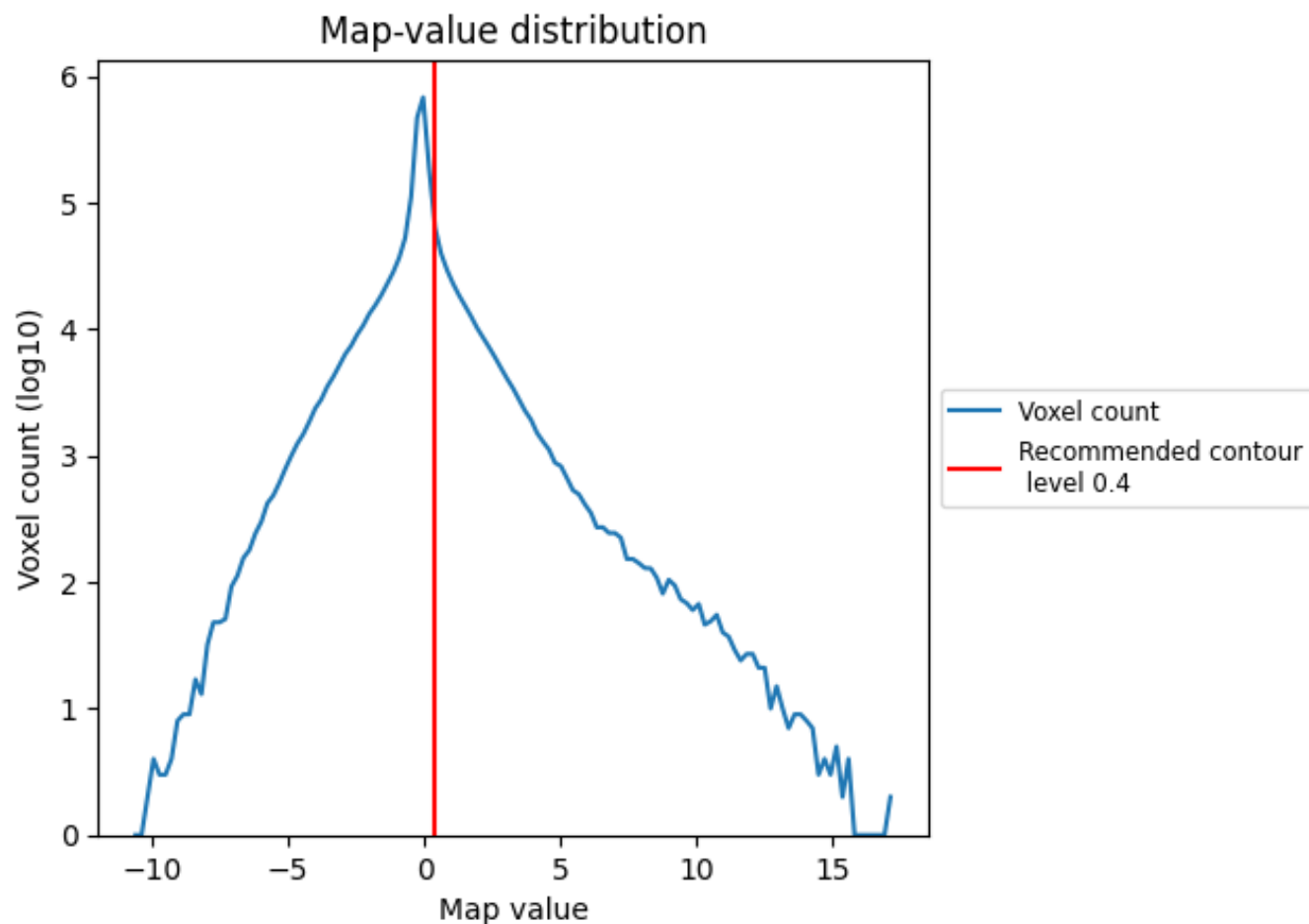

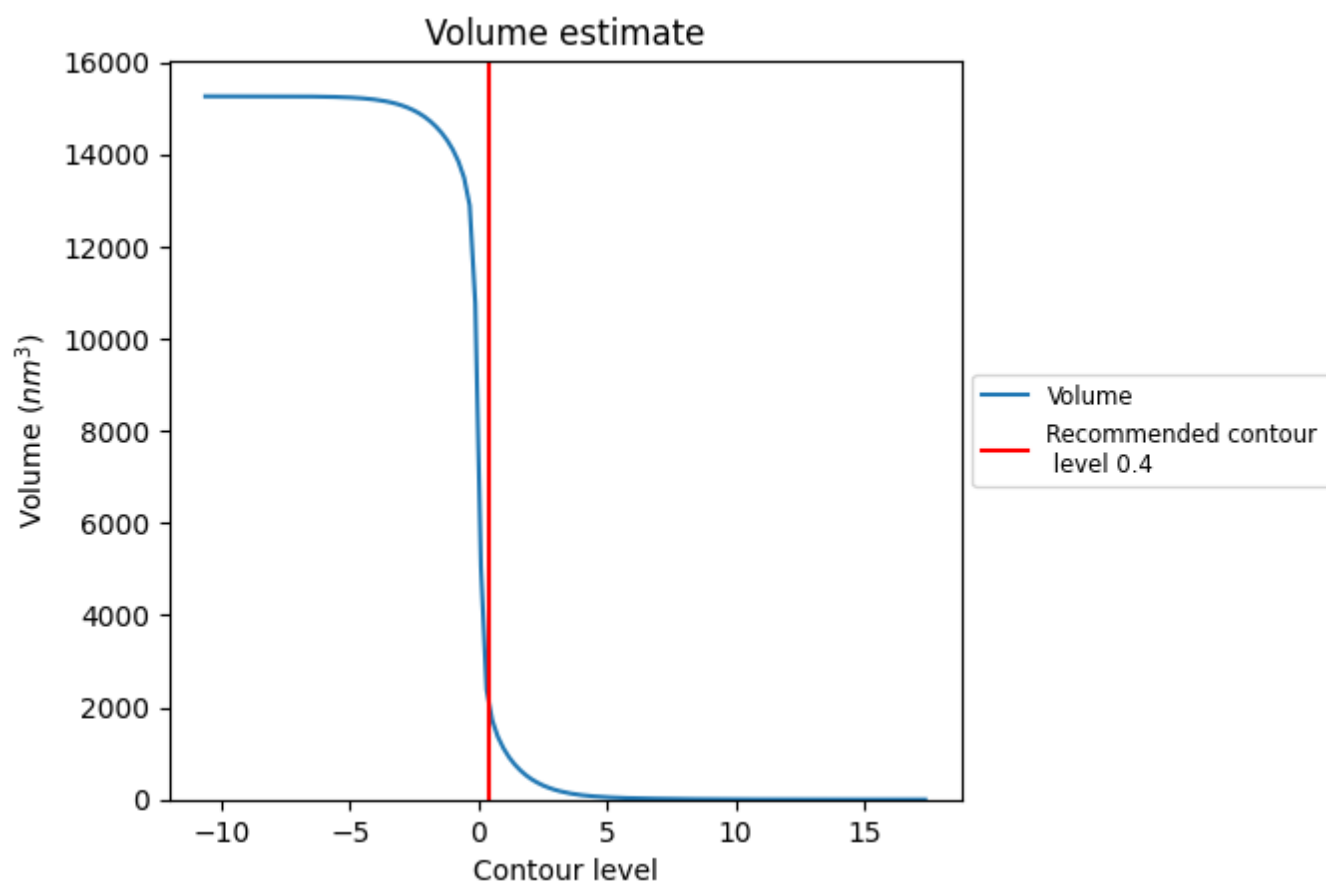
This section contains the results of statistical analysis of the map.

#### 3.1 Map-value distribution [i](#)



The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.

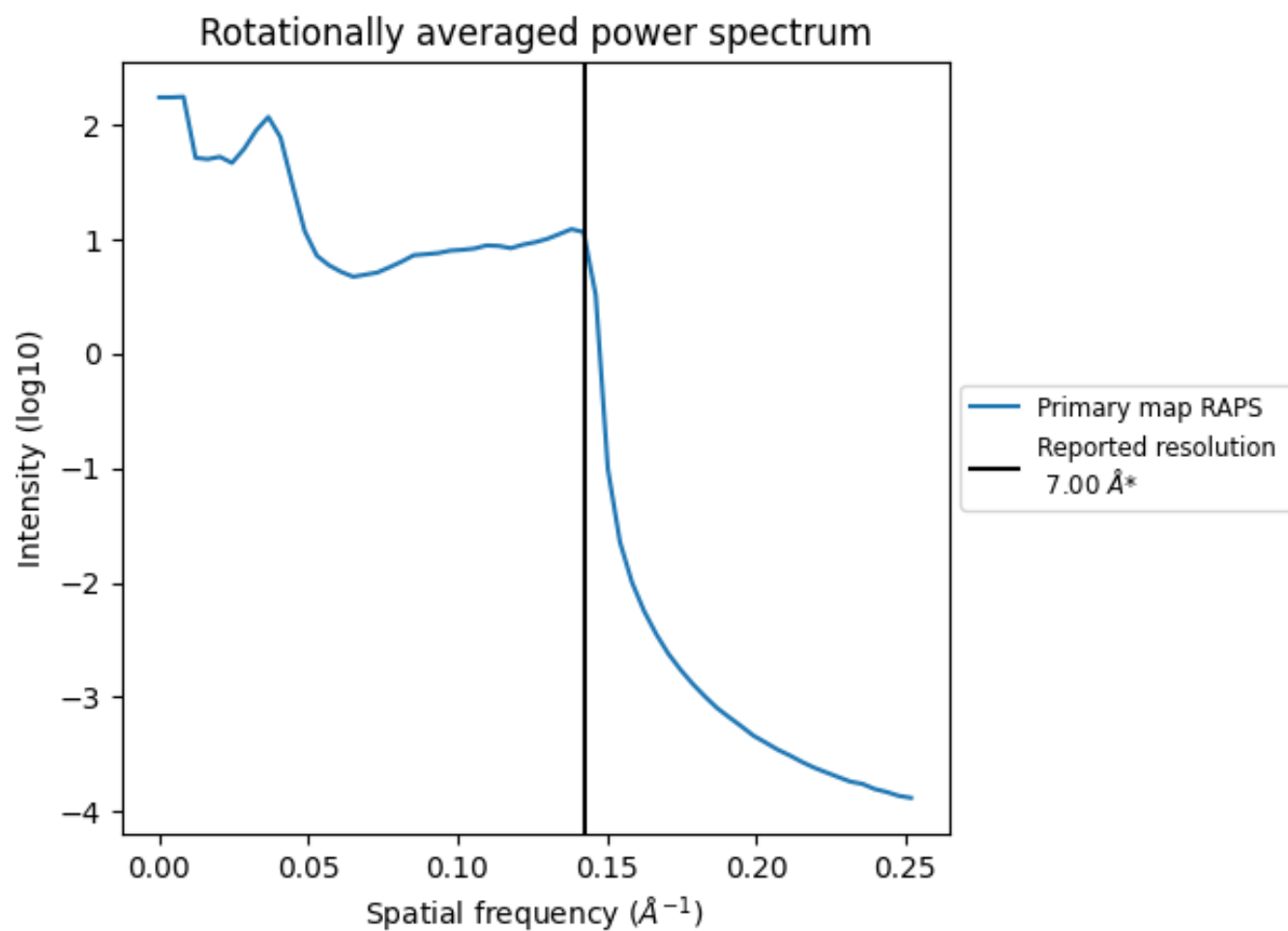
### 3.2 Volume estimate [i](#)



The volume at the recommended contour level is 2125 nm<sup>3</sup>; this corresponds to an approximate mass of 1920 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.
